At **Modernage Public School & College** (maps.edu.pk), we are committed to safeguarding the privacy and personal data of our students, parents, staff, job applicants, and site visitors. This policy explains how we collect, use, and protect your information across our website, online submission forms, payment portals, and school management systems.

1. Information We Collect

We collect information necessary to deliver educational, administrative, and portal services:

- **Online Forms Data:** Full names, CNIC/B-Form numbers, contact details, email addresses, residential addresses, and academic histories provided via admission applications, inquiry forms, and employment submissions.
- **Student & Parent Data:** Grades, attendance, fee statuses, disciplinary records, and communications managed via our secure Management Information System (MIS) and Student/Parent Portals.
- **Financial & Payment Data:** Payment status, transaction IDs, and fee breakdown details processed when using online fee payment channels.

*Note: Full credit/debit card details or banking credentials are processed directly by PCI-DSS compliant payment gateways and are **never** stored on our servers.*

- **Visitor & System Data:** IP addresses, browser types, device information, access timestamps, and essential session cookies collected automatically to monitor portal security and site performance.

2. How We Use Your Information

We use the collected data strictly for institutional and educational operations:

- Processing admissions, student registrations, and fee collection.
- Managing student academic records, progress reports, and parent communications via web portals and mobile apps.
- Evaluating job applications and recruitment requirements.

- Maintaining system security, verifying user logins, and preventing unauthorized portal access.

3. Data Protection & Sharing

- **Minor & Student Privacy:** Student personal data is treated with high confidentiality and accessible only by verified parents/guardians and authorized school personnel.
- **Third-Party Service Providers:** We do not sell, rent, or trade personal data. Data is shared only with trusted technical providers under confidentiality agreements (e.g., website hosts, database cloud platforms, and banking gateways).
- **Legal Disclosure:** Information may be disclosed if required by Pakistani law enforcement or official educational authorities.

4. Security Measures

We enforce multi-layered security protocols to safeguard electronic records:

- **SSL/TLS Encryption (<https://>)** on all public forms and login portals.
- **Role-Based Access Control** ensuring users only see information relevant to their accounts.
- Regular security maintenance and database backups.

5. Cookies & Tracking

Our website uses essential technical cookies required for portal navigation and user authentication. Users may disable cookies in browser settings, but doing so may restrict access to logged-in portal features.
